For participation in the Alaska Cruiser Trek (ACT), the undersigned hereby agrees to release and hold harmless any owners, sponsors, trail guides, workers, and owners of both public and private land where the ACT is held. This shall also include officers, directors, agents and employees of the ACT and the ACC (Alaska Cruiser Crew). The above shall also be released from any negligent act or omission and shall also include any loss damage or cost incurred due to participation in this event. The participant shall understand and assume full responsibility and risk for any property damage, injury or death while participating in this event. The applicant acknowledges that they fully understand that vehicular off road activities and other recreational pursuits in remote areas are inherently unpredictable and potentially risky, and these risks can be beyond the ability of the Alaska Cruiser Crew or any others associated with the Alaska Cruiser Trek to control. In signing this release, each participant hereby agrees to the following:

- (A) The owner/operator certifies that the participating vehicle has been inspected & that it is in good working order.
- (B) That each participant has informed himself/herself about the event and the trails involved in the event.
- (C) That he/she has read all the foregoing Releases and Waiver of Liability and Indemnity Agreement.
- (D) Participants acknowledge that trail riding is hazardous, dangerous, and unpredictable.
- (E) Participating event vehicle must pass ACT/ACC inspection.

THIS WAIVER MUST BE SIGNED BY ALL PARTICIPANTS

For a child under 18 years of age, both parents, the parent with legal custody, or the minor's legal guardian must sign this release form and write the word "minor" and age next to the minor's name.
